Public Services –Amendment to Special Rules for Tamil Nadu Basic Service – Direct Recruitment – Enhancement, of age limit from 30 to 32 years to Backward Classes, Backward Class Muslims, Most Backward Classes and Denotified Communities – Orders - Issued.

#### ORDER:

Orders were issued in the Government orders read above that the candidates belonging to Most Backward Classes, Denotified Communities and Backward Classes respectively, who do not possess a qualification higher than the Minimum General Educational Qualification (SSLC), the age limit for direct recruitment to the posts for which SSLC or below is prescribed as the minimum educational qualification at entry level, be enhanced from 30 (Thirty) to 32 (Thirty two) years. The Special Rules for Tamil Nadu Basic Service shall be amended suitably. Accordingly, the following Notification will be published in the Tamil Nadu Government Gazette:-

## **NOTIFICATION**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for Tamil Nadu Basic Service (Section 19 in Volume III of the Tamil Nadu Services Manual, 2016).

- 2 (i). The amendments (1) and (4) hereby made shall be deemed to have come into force on the 20<sup>th</sup> October 1993.
- (ii) The amendment (2) hereby made shall be deemed to have come into force on the  $3^{\rm rd}\,$  May 2002.
- (iii) The amendment (3) hereby made shall be deemed to have come into force on the 15<sup>th</sup> September 2007.

## **AMENDMENTS**

In the said Special Rules, in rule 5, in sub-rule (1), -

- (1) after the first proviso, the following proviso shall be inserted, namely:-
  - "Provided further that the candidates belonging to Most Backward Classes and Denotified Communities, who do not possess a qualification higher than the Minimum General Educational Qualification, shall be eligible for appointment to the above classes, if he has not completed 32 years of age on the date of appointment:";
- (2) in the second proviso as so inserted, for the expression "Most Backward Classes", the expression "Backward Classes, Most Backward Classes" shall be substituted;
- (3) in the second proviso as so amended, for the expression "Backward Classes, Most Backward Classes", the expression "Backward Classes, Backward Class Muslims, Most Backward Classes" shall be substituted;
- (4) in the third proviso, for the word "further", the word "also" shall be substituted.
